to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Daisy Lee Lachen and Autry Lachen,

All that piece, parcel or lot of land in the city of Greenville, state of South Carolina, known and designated as Lot 23 on plat of Carver Park made by Piedmont Engineering Service, October, 1951, and recorded in the R. M. C. Office for Greenville County in plat book "AA", page 187, and having according to said plat the following courses and distances, to-wit:

Beginning at an iron pin on Gaston Street, joint front corner of Lots 22 and 23 and running thence along the line of Lot No. 22 N. 47-0 W. 122.7 feet to an iron pin on line of Lot No. 50; thence along the line of Lot No. 50 S. 43-0 W. 60 feet to an iron pin corner of Lot No. 24; thence along the line of Lot No. 24 S. 47-0 E. 122.7 feet to Gaston Street; thence along Gaston Street N. 43-0 E. 60 feet to the beginning corner.

The lot above described is conveyed subject to the covenants and restrictions recorded in the R. M. C. Office for Greenville County in deed book 444, page 436, which are made a part hereof as fully as if set out herein, and to the public utility easement granted to the Duke Power Company, which is recorded in said R. M. C. Office in Deed Book 445, page 235.

Being the same property conveyed to grantor by G. Dewey Turner by deed dated January 22, 1953 recorded in deed book 470 page 473 of the R. M. C. Office for Greenville County.
