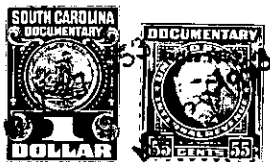

All that certain piece, parcel or lot of land situate, lying and being in Austin Township, Greenville County, State of South Carolina, near the Town of Mauldin and containing .88 acres more or less and being on the South side of Sunrise Drive and having according to plat of Hendrix and Reid made by C. O. Riddle May 14, 1953, and recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book DD, Page 125, the following metes and bounds, to-wit:
