

BEGINNING at an iron pin on the South side of Randall Street at the joint front corner of Lots 47 and 49, which pin is 400 feet easterly from the southeastern intersection of Randall and Townes Streets, and running thence along line of Lot No. 47, S. 1-41 W. 200 feet to an iron pin on an un-named alley; thence along the north side of un-named alley, N. 83-13 E. 100 feet to an iron pin at the joint rear corner of Lots 49 and 51; thence along the line of Lot 49, N. 1-41 E. 200 feet to an iron pin on the South side of Randall Street; thence along the South side of Randall Street N. 83-13 W. 100 feet to the beginning corner.
