E. HOLTON, HIS HEIRS AND ASSIGNS, FOREVER:

All those pieces, parcels or lots of land in Chick Springs Township, Greenville County, State of South Carolina, situate, lying and being on the Southwestern corner of the intersection of Lee Road and Mayfair Drive and being known and designated as Lots Nos. 1 and 2, Block D, of Mayfair Estates as shown on Plat thereof recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book S, page 72, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of Lee Road, joint front corner Lots Nos. 2 and 3, and running thence with the joint line of said lots, S. 16-38 E. 150 feet to an iron pin in the line of Lot No. 5; thence with the line of Lot No. 5, N. 73-22 E. 96.4 feet to an iron pin on the Western side of Mayfair Drive; thence along the Western side of Mayfair Drive, N. 15-15 W. 135 feet to an iron pin at the intersection of Mayfair Drive and Lee Road; thence around the corner of said intersection in a curved line (the chord of which is N. 59-55 W. 21 feet) to an iron pin on the Southern side of Lee Road; thence with the Southern side of Lee Road, S. 73-22 W. 35 feet to the beginning corner.
