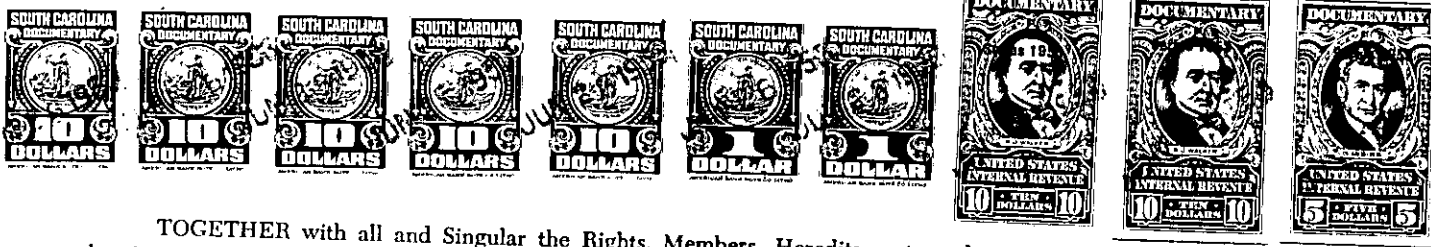
Norman R. Seibert, his heirs and assigns forever:

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being at the Northwesterly corner of the intersection of Crestwood Drive and Hillandale Circle, near the City of Greenville, South Carolina, being shown as part of Lot No. 1 on the plat of the property of J. M. Black as recorded in the RMC Office for Greenville County, S. C., in Plat Book "S", page 59, and having according to said plat the following metes and bounds, to-wit:

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

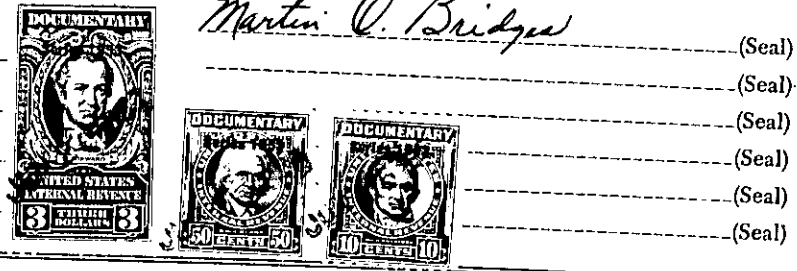
