BEGINNING at a point on the east side of Summit Drive, the joint corner of May H. Powell and Benson C. Parrish, and running thence N 23 - 20 E. 5.6 feet to a point; thence along Summit Drive N 43 - 17 E. 39.0 Feet to a point on the southeast corner of Reid Street and Summit Drive; thence S 81 - 35 E. 6.2 feet along Reid Street to a point; thence back along Summit Drive S 43 - 33 W. 44.4 feet to the beginning corner.

The strip of land above described is to be used for the purpose of widening Summit Drive.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and its successors and Assigns forever.
