Bagwell and Ernest Pittman, and running thence N 22 - 22 W 6.3 feet to a point; thence along Summit Drive N 43 - 17 E 75.0 feet to a point; thence S 23 - 20 W 5.9 feet to a point; thence back along Summit Drive S 43 - 33 W 61.0 feet to a point; thence still along said street S 43 - 0 W 15.0 feet to the beginning corner

AS A FURTHER CONSIDERATION THE CITY AGREES TO PAVE THE DRIVEWAY TO PROPERTY LINE FROM SIDEWALK.

The strip of land above described is to be used for the purpose of widening Summit Drive.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
