BEGINNING at a point on the northeast corner of Northwood Avenue and running thence N 87 - 34 W 5.7 feet with said street; thence N 1 - 26 E 85.0 feet along Summit Drive to a point; thence S 87 - 34 E 6.0 feet to a point; thence back along Summit Drive S 1 - 43 W 85.0 feet to the beginning corner

The strip of land above described is to be used for the purpose of widening Summit Drive.
