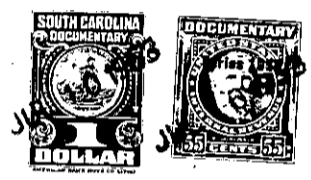
Know All Men by These Presents:

All that piece parcel or lot of land lying and being in Highland township, Greenville county, South Carolina lying on the south side of the road leading from Camp Creek to Greer, Joined on the west by Odom land and south by Jenkinsland and east by Stokes.

S76.00E 113 ft. to a bend thence. S29 E 26 ft. to a bend. thence. S70.30 E 47.5 ft to a bend thence. S59.40 E 82 ft. to a bend thence. N62.00E 44 ft. to a stake on the old line in the old road line Thence. with the old road line N34.30 W 228 ft. to a pin. in old road. thence. N25.30 W 243 ft. to a stake in old road. thence.
