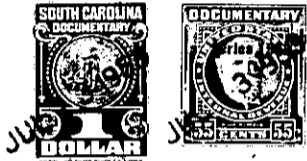
Know All Men by These Presents:

Atkins, Surveyor, on March 4, 1914 with the following metes and bounds: Beginning at a stone on the Spartanburg and Greenville line, near Landrum, S.C., and running S. 72 3/4 W. for a distance of 10.61 to a stone; thence running N. 733 W. for a distance of 1266 to an old stake; thence S. 41 E. for a distance of 390 to a new stone; thence S. 32 3/4 E. for a distance of 776 to the beginning corner. This being lot No. 6 in the subdivision of the land belonging to Susan O'Shields and being bounded on the South by lot No. 7, on the West by the property of the Estate of Alexander Prewitte and on the Northwest by lands of Perry Campbell, and on the East by lot No. 5.
