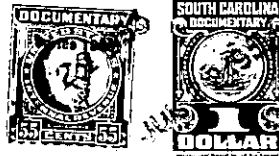


STATE OF SOUTH CAROLINA, GREENVILLE COUNTY



Know All Men by These Presents:

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

E. H. Burns, his heirs and assigns: all that piece, parcel or lot of land situate, lying and being in East Gantt Township, Greenville County, South Carolina, being known and designated as Lot No. 15 on plat of property of Grantor, made by C. C. Riddle, Surveyor, June 2, 1953, and according to said plat, having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the Southeast intersection of Fairfield Road and Lanford Drive, and running thence with Lanford Drive the following courses and distances, to-wit: S. 60-37 E., 35 feet; S. 70 E., 50 feet; S. 81-05 E., 50 feet; S. 86-42 E., 9 feet to the joint front corner of Lot No. 14; thence with line of Lot No. 14 S. 2-50 W., 75 feet; thence N. 86-42 E., 215 feet to an iron pin on the Southeasterly side of Fairfield Road; thence with said road N. 38-08 E., 134 feet to the point of beginning.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.
