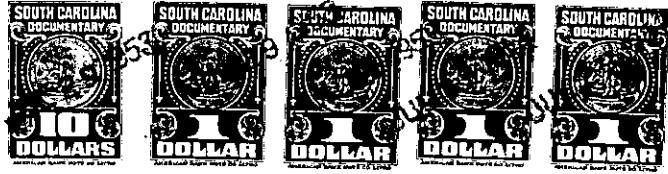

Know All Men by These Presents:

That I, J. N. Brannon, in the State aforesaid, in consideration of the sum of - - - Sixty-Nine Hundred (\$6,900.00) - - - - - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Mrs. Burwell J. Jones, her heirs and assigns:

ALL that piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, known as Lots 28, 29 and 30 of a subdivision known as East Lynne, as shown in Plat Book "H" at page 195 in the R.M.C. Office for Greenville County, South Carolina, and, according to said plat, having the following metes and bounds:

BEGINNING at an iron pin on the South side of Lowndes Hill Road, joint corner of Lots 30 and 31, said pin being 100 feet in a Westerly direction from the intersection of Lindsay Avenue and Lowndes Hill Road; thence S. 9-14 E. 164.4 feet with the line of Lots 30 and 31 to an iron pin; thence S. 81-02 W. 75 feet to an iron pin in the joint rear corners of Lots 27 and 28; thence N. 9-14 W. 164 feet to an iron pin on the Lowndes Hill Road; thence N. 80-43 E. 75 feet to the beginning corner.

This being the same property which was conveyed to the Grantor by deed of Robert Rubin Bishop, dated July 10, 1951, and being recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 438 at page 36.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.

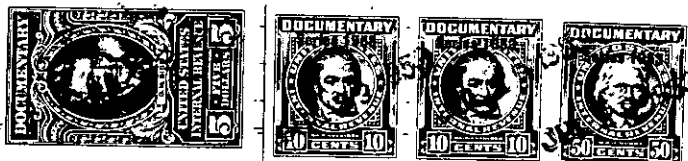
