Joseph C. Jones, his heirs and assigns, forever.

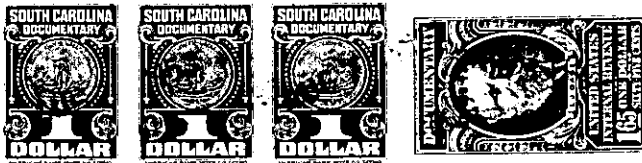

Office for Greenville County, S. C., in Plat Book "GG", at Pages 2 and 3, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwest side of Scarlett Street, at joint front corner of Lots 161 and 162, and running thence with the line of Lot 161, N.59-08 W. 210 feet to an iron pin; thence N. 26-54 E. 73.5 feet to an iron pin; thence with the line of Lot 163, S. 58-16 E. 216.3 feet to an iron pin on the northwest side of Scarlett Street; thence with the northwest side of Scarlett Street, S. 31-33 W. 75 feet to the beginning corner.
