Know All Men by These Presents:

That I, Donald E. Baltz in the State aforesaid, in consideration of the sum of Thirty-four Hundred Fifty (\$3450.00) DOLLARS, and assumption of mortgage to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said James P. Hester,

All that certain piece, parcel or lot of land in Greenville Township, in the city of Greenville, Greenville County, state of South Carolina, being known and designated as lot No. 15 of the property of Donald E. Baltz as shown on plat thereof recorded in plat book Y page 46 of the R. M. C. Office for Greenville County, and having according to a recent survey made August 1953 by R. W. Dalton, the following metes and bounds, to-wit:

Beginning at an iron pin on the southwest side of Don Drive, the joint front corner of lots Nos. 15 and 16, and running thence with the joint line of said lot S. 32-07 W. 150 feet to an iron pin corner of lot No. 24; thence with the line of said lot N. 57-53 W. 75 feet to an iron pin corner of lot No. 14; thence with the line of said lot N. 32-07 E. 150 feet to an iron pin on the southwest side of Don Drive; thence with the southwest side of said street S. 57-53 E. 75 feet to the beginning corner.

Being a portion of the property conveyed to grantor by Lucy W. Gifford by deed dated January 31, 1951, recorded in deed volume 428 page 170, of the R.M.C. Office for Greenville County.

The grantee assumes and agrees to pay the balance of \$6200.00 due on that certain mortgage given by the grantor to John T. Wilkins in the amount of \$6,000 dated February 6, 1953 recorded in volume 553 page 10 of the R. M. C. Office for Greenville County.
