That I, Lloyd Johnson, Grantor, in the State aforesaid,
in consideration of the sum of Two thousand (\$2000.00)----- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt, whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Miles Lasco Clayton, Grantee, and his heirs and assigns, forever, all of that certain piece, parcel or lot of land, with improvements thereon, located in said State and County, O'Neal Township, about six miles North from Greer, lying on the North side of the road that leads from Mt. Lebanon Road to and by the home of J.P. Ballenger, and being all of the same lot of land conveyed to me by Thomas Earle Thompson by deed dated the 6th. day of May 1950 and recorded in the Office of R.M.C. for Greenville County in Deed Book Vol. 412 at page 350, and having the following courses and distances:-

BEGINNING on a stake in the north edge of the said road and on the J.H. Gibson line, and being the joint corner of the Bruce land, and runs thence with the J.H. Gibson line N. 4-00 E. 208.6 feet to a stake on said line; thence S. 86-00 E. 208.6 feet to a stake; thence S. 4-00 E. 208.6 feet to a stake in or near the center of the said road (stake also back on line on the north bank of the road); thence with the said road S. 86-00 E. 208.6 feet to the beginning corner, containing one (1) acre, more or less.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s)' Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee(s)' Heirs and Assigns against the grantor(s) and the grantor(s)' Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
