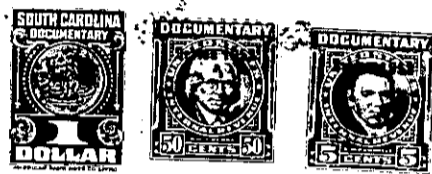
Know All Men by These Presents:

Smith, his heirs and assigns forever:

All that certain piece, parcel, lot or tract of land lying, situate and being in Cantt Township, Greenville County, South Carolina, and known and designated as Lot No. 8 of the R. L. Rollins property, according to survey made by W. J. Riddle, Surveyor, May 1951, and having the following metes and bounds:

BEGINNING at an iron pin in the elbow of Reeves Road and running thence with Reeves Road South 0-28 E. 180 feet to line of lot No. 7; thence with line of said lot No. 7 N. 88-21 W. 165 feet to joint rear corner lots Nos. 7, 8 and 9, said plat; thence with joint line of said lots Nos. 8 and 9 N. 21-13 E. 214.2 feet to Reeves Road; thence with Reeves Road S. 73-50 E. 89.4 feet to the point of beginning, and being a portion of the property conveyed to R.
