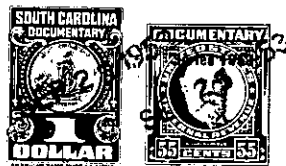
That I, J. Frank Williams

D. M. Holder, Jr., his heirs and assigns, all that certain piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, and being known and designated as Lot No. 24 of the subdivision known and Pine Grove Heights, plat of which is recorded in the RMC office in plat book "Y" at page 87, and according to said plat having the following metes and bounds, to-wit:

BEGINNING at a point on the northern side of Pine Grove Road, joint front corner of Lots Nos. 23 and 24, and running thence with the line of said lots, N. 25-30 E., 160 feet; thence S. 64-30 E., 100 feet; thence with the line of Lots Nos. 24 and 25, S. 25-30 W., 160 feet to a point on the northern side of Pine Grove Road; thence with Pine Grove Road, N. 64-30 W., 100 feet to the point of beginning.
