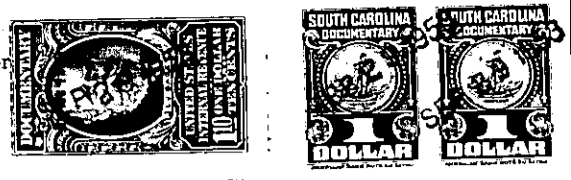

C. Jones, Engr. and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin at the joint front corner of Lot No. 34 and Lot No. 35 on View Point Road and running thence with View Point Road South 74-29 West 74.8 feet to an iron pin at the joint front corner of Lot No. 34 and Lot No. 33; running thence along the joint line of said lots, South 25-31 East 150 feet to an iron pin; running thence North 74-43 East 66 feet to an iron pin; running thence North 22-07 West 149 feet to an iron pin on View Point Road, the beginning corner.
