Know All Men by These Presents:

That I, D. B. Tripp, in consideration of the sum of Six hundred no/100 in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Ellie B. Taylor, her heirs and assigns forever

All that certain lot of land in Paris Mountain Township, Greenville County, State of South Carolina, near the Duncan Chapel Road, being a portion of the J. E. Thackston Home Place, and being known as Lot No. 7 on plat designated as "Map No. 1, Montague Circle", property of D. B. Tripp, as per survey and plat by C. O. Riddle, L. S., August 24, 1953, recorded in Plat Book EE, page 33, and having the following metes and bounds according to said plat:

BEGINNING at an iron pin at the corner of Montague Circle and an unnamed Street (at edge of an 8-foot strip reserved for sidewalk) and running thence with Montague Circle N. 19-20 E. 100 feet to iron pin at corner of Lot No. 6 on said plat; thence with line of Lot No. 6, N. 70-40 W. 200 feet to an iron pin in line of Lot No. 8; thence with line of Lot No. 8, S. 19-20 W. 100 feet to stake on edge of an unnamed Street; and thence with said Street S. 70-40 E. 200 feet to beginning corner, being a portion of the tract conveyed to me by P. K. Thackston, et al, by deed dated January 31st, 1947, and recorded in Book 307, page 69.

This property is conveyed subject to the following conditions and restrictions:

- (1) Said property is to be used for residential purposes only.
 - (2) No residence shall be erected on any lot in said subdivision costing less than \$6,500.00.
 - (3) The building line as shown on said plat shall be adhered to.
 - (4) No cattle, hogs, or live stock of any kind, shall be kept on the premises.
 - (5) No residence is to be built on any lot or portion thereof, unless said lot has 100 feet, or more, of street frontage.
- Grantor to pay 1953 Taxes.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.
