to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

MRS. ELMER TOLLISON, her heirs and assigns forever

ALL that piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina, being known and designated as the greater portion of Lot No. 6 of the property of Conestee as shown on plat thereof prepared by R. E. Dalton, Engr., December 1943 and recorded in the RMC Office for Greenville County in Plat Book "K", at page 276, and having according to said plat, the following metes and bounds, to wit:

BEGINNING at a point on the South side of Fourth Avenue, which point is 10 feet from the joint front corner of Lots 6 and 7 and running thence with the South side of Fourth Avenue, South 61-20 East 75 feet to the joint corner of Lots 5 and 6; thence South 28-40 West 75 feet to the joint corner of Lots 4 and 5; thence with line of Lots 3 and 4, South 50-20 West 107.6 feet to joint rear corner of Lots 6 and 3; thence with line of Lot No. 2, North 61-20 West 45 feet to joint corner of Lots 6 and 7; thence with the new line in a Northeasterly direction 175 feet, more or less, to the point of beginning and being all of Lot No. 6, except a 10-foot strip which is triangular in shape.

This being the same property conveyed to Lona Belle Taylor by deed of Richard I. Tollison, Jr. and recorded in Deed Book 414, at page 242, RMC Office for Greenville County.
