Ralph Darby, his heirs and assigns forever:

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the Southwesterly side of Mayo Drive, near the City of Greenville, S. C., being shown as Lot No. 174 on the plat of Paramount Park as recorded in the REC Office for Greenville County, S. C. in Plat Book "1.", page 57, and having according to said plat the following notes and bounds, to-wit:

BEGINNING at an iron pin on the Southwesterly side of Mayo Drive at the joint front corner of Lots Nos. 173 and 174, said pin being located 75 feet Northwest of the Westerly intersection of Mayo Drive and Crosby Circle, and running thence along the Southwesterly side of Mayo Drive N 26-0 W 80 feet to an iron pin, joint front corner of Lots Nos. 174 and 175; thence along the joint line of Lots Nos. 174 and 175 S 64-0 W 150 feet to an iron pin in the line of Lot No. 176, which is also the center line of a 10 foot strip reserved for utilities; thence along the center line of said 10 foot strip S 26-0 E 80 feet to an iron pin in the line of Lot No. 172; thence along the joint line of Lots Nos. 173 and 174 N 64-0 E 150 feet to the point of beginning.
