

" RIL GENERAL POWER OF ATTORNEY KNOW ALL MEN BY THESE PRESENTS: That I, the undersigned,

 $\mathcal{C}_{\mathcal{F}}$ Joseph Hamilton Bolick , a legal resident of the city of Marietta , County of Greenville State of , now in or accompanying the military South Carolina service as a 2nd Lieutenant , (Army Serial No. in or with the Army of the United States and temperarily residing at 5 Briar Hill Court, Osark, Alabama have made, constituted and appointed, and by these presents do make, constitute and appoint my wife, Jean Hester Bolick whose present address is 44 Webster Street, Slater, South Carolina my true and lawful attorney to act in, manage, and conduct all my estate and all my affairs, and for that purpose for me and in my name, place, and stead, and for my use and benefit, and as my act and deed, to do and execute, or to concur with persons jointly interested with myself therein in the doing or executing of, all or any of the following acts, deeds, and things, that is to say:

- 1. To buy, receive, lease, accept or otherwise acquire; to sell, convey, mortgage, hypothecate, pledge, quitclaim, or otherwise encumber or dispose of; or to contract or agree for the acquisition, disposal, or encumbrance of any property whatsoever or any custody, possession, interest or right therein, upon such terms, considerations and conditions as my said attorney shall think proper;
- 2. To take, hold, possess, invest, lease, or let, or otherwise manage any or all of my property or any interest therein; to eject, remove, or relieve tenants or other persons from, and recover possession of, such property by all lawful means; and to maintain, protect, preserve, insure, remove, store, transport, repair, build on, raze, rebuild, alter, modify, or improve the same or any part thereof;

To make, do, and transact all and every kind of business of what nature or kind soever, including the receipt, recovery, collection, payment, compromise, settlement, and adjustment of all accounts, legacies, bequests, interests, dividends, annuities, demands, debts, taxes, and obligations, or any rebate, refund or discount thereon, which may now or hereafter be due, owing or payable by me or to me.

To make, indorse, accept, receive, sign, seal, execute, acknowledge, and deliver deeds, assignments, agreements, certificates, hypothecations, checks, notes, vouchers, receipts, and such other instruments in writing of whatever kind and nature as may be necessary, convenient, or proper in the premises;

To deposit and withdraw for the purposes hereof, in either my said attorney's name or my name or jointly in both our names, in or from any banking institution, any funds, negotiable paper, or moneys which may come into my said attorney's hands as such attorney or which I now or hereafter may have on deposit, or be entitled to: ......
