to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said B. T. Reeves, his heirs and assigns forever:

All that piece, parcel or lot of land in Greenville County, State of South Carolina, lying in Austin Township, about six miles East of Simpsonville, S. C. near Clear Springs Church, and known as tract seven (7) on a plat of property made for W. O. Lewis by J. C. Bruce, Surveyor, Sept. 29, 1953, and having the following metes and bounds according to said plat. (Outside lines taken from plat by L. A. Austin, outside lines not rerun.)

Beginning at a nail or stopper in the center of a hard surface treated road at the joint corner of tracts 5 and 8 and running South down the center of the road, road the line to a point in the center of the said road at the south corner of lot 8; thence S. 16-45 W., 264 feet past the corner of tract 8 to a point in the center of the said road; thence N. 7-30 W., 2689.5 feet to a point at the corner of tract 5; thence N. 85 E., along the line of tract 5 to a point in the center of the said road and the beginning corner, and containing 26.4 acres more or less.
