Know All Men by These Presents:

That I, W. H. Revis in the State aforesaid,
in consideration of the sum of TWENTY THOUSAND AND NO/100 (\$20,000.00) - - - - -DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said JAMILE J. FRANCIS, his heirs and assigns:

All that certain piece, parcel or tract of land situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, on the ^{WHR} Northeasterly side of Pleasantburg Drive, North (State Highway # 291) and on the North side of the White Oak Road and having, according to a plat made by L. P. Slattery, Registered Engineer, in December, 1953, the following metes and bounds, to-wit:

^{WHR} BEGINNING at an iron pin on the Northeasterly side of Pleasantburg Drive, North (State Highway # 291), which iron pin is 400 feet in a Southeasterly direction from an iron pin on Galphin Road, and running thence N. 36-22 E. 1001.6 feet to an iron pin on a branch; thence with said branch as the line S. 43-20 E. 246 feet to an iron pin; thence S. 39-40 W. 535.5 feet to an iron pin; thence S. 3-10 W. 411.6 feet to an iron pin in the White Oak Road; thence along the White Oak Road N. 86-50 W. 305.6 feet to an iron pin; thence N. 39-50 E. 30.35 feet to a point; thence N. 40-06 W. 190.6 feet to a point in the center of an old road; thence N. 36-22 E. 12.25 feet to an iron pin, the point of beginning.

This is the same property deeded to the grantor herein by deeds recorded in R.M.C. Office for Greenville County, South Carolina, in Deeds Volume 282, page 264, and 285, page 361, and includes all of the right, title and interest of the grantor in and to an old roadway on the Southwest side of the property which was abandoned upon the construction of Pleasantburg Drive North (State Highway # 291).

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

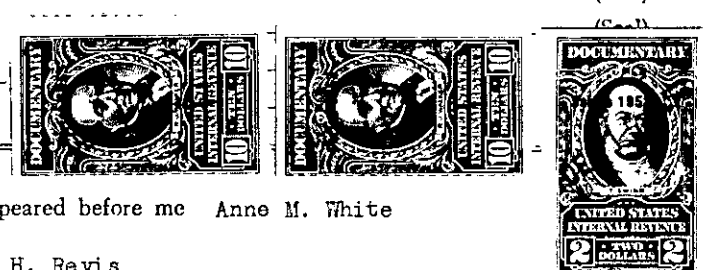
