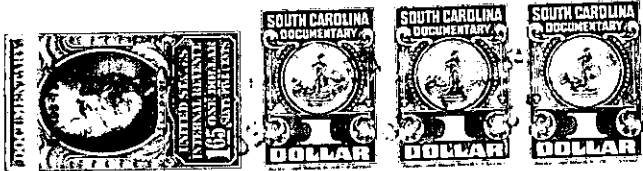

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Mollie Young Sullivan, her heirs and assigns:

All that certain piece, parcel or lot of land, situate, lying and being in Greenville County, State of South Carolina, located on the southwest side of the White Horse Road approximately .6 of a mile west of the intersection of Augusta Road and White Horse Road, and being known as Lot No. 2 as shown on plat of the Roseman Heights, said plat of record in the R.M.C. Office for Greenville County in Plat Book "T", at page 473, and more fully described as follows:

BEGINNING at an iron pin on the southwest side of White Horse Road, said iron pin being the joint front corner of Lots Nos. 1 and 2 of Roseman Heights, and being 100 feet from the western intersection of Terry Court and White Horse Road and running thence S. 44-05 W. 179.4 feet to a stake, joint rear corner of Lots Nos. 1 and 2; thence S. 45-55 E. 99.9 feet to an iron pin on the western side of Terry Court, said iron pin being the rear corner of Lot No. 2 and the northwest corner of Lot No. 3; thence along the western side of Terry Court N. 44-05 E. 183.3 feet to an iron pin at the western intersection of the White Horse Road and Terry Court; thence N. 48-10 W. 100 feet along the southwestern side of the White Horse Road to an iron pin, point of beginning.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.
