All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, west of and near City of Greenville, north of and near Bramlett Road, fronting on northern side of Arch Street Extension, being shown and designated as Lot Number Ten (No. 10) on a plat of the property of F. B. Massingale, made by J. Coke Smith & Son, Surveyors, May 15, 1947, and, according to said plat, having the following metes and bounds, to-wit:

BEGINNING at a point on northern side of Arch Street Extension, joint front corner with Lot No. 11 of said plat, and running thence in a northwesterly direction along the western line of said Lot No. 11, One Hundred Sixty (160) feet to point, joint rear corner with Lot No. 11; thence S. 60-40 W. 60 feet to point, joint rear corner with Lot No. 9; thence in a southeasterly direction along the eastern line of Lot No. 9 to point on northern side of Arch Street Extension, 160 feet, joint front corner with Lot No. 9; thence in a northeasterly direction along the northern side of Arch Street Extension, Sixty (60) feet to the point of beginning.
