which point is in the western line of property of Piedmont Realty Corporation fronting on East Washington Street, and is also at the corner of property heretofore conveyed by Piedmont Realty Corporation to John A. McPherson, et al,; thence in a westerly direction 10 feet, more or less, to a point at the joint rear corner of property of the said John A. McPherson, et al, and grantor herein; thence along the rear line of property of Piedmont Realty Corporation in a scutherly direction 51.55 feet, more or less, to a point on the north side of East Washington Street; thence along the north side of East Washington Street in an easterly direction 10 feet, more or less, to the beginning corner.

The above-described property is that portion of what was formerly a private 10-foot alley at the rear of the two lots of Fiedmont Realty Corporation herein conveyed which front on the East side of North Main Street.
