That We, John Q. Metcalf and M. Ione Metcalf, in the State aforesaid, in consideration of the sum of SIX THOUSAND, TWO HUNDRED NINE and 61/100 (\$6,209.61) - - - - DOLLARS, plus assumption of mortgage listed below, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

JAMES F. HANN, his heirs and assigns:

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, about two miles North of the City of Greenville, being shown as Lot No. 23 on Plat of Perry Property recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book Q, at page 26, and having, according to a more recent survey made by J. C. Hill on December 5, 1949, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern edge of a five-foot sidewalk running along Beacon Street, said pin being joint corner of Lots Nos. 23 and 24, said pin being 120 feet from the intersection of Beacon Street and Berkley Street and running thence along the edge of said sidewalk 147 feet 60 feet to an iron pin at the corner of Lot No. 22; thence with the line of Lot No. 22 S. 80-52 E. 150.6 feet to an iron pin; thence along the rear of Lot No. 23 S. 26-43 W. 62.5 feet to an iron pin at corner of Lot No. 24; thence with the line of Lot No. 24 W. 80-52 W. 139.4 feet to the beginning corner.

As part of the consideration herein, the grantee assumes and agrees to pay that certain mortgage executed by John Q. and M. Ione Metcalf to Fidelity Federal Savings & Loan Association, dated December 9, 1949, and recorded in R.M.C. Office for Greenville County, South Carolina, in Mortgages Volume 444, page 317.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
