Beginning at a point on an unnamed street which runs off Haynswoth Road in an Easternly direction, said point being the joint corners of lots 9 and 8; thence running S. 64 W 270 feet to a point that is the joint corners of lots 9, 8, 7, and 6; thence S. 38 W. 90 feet to a point midway of the back joint line of lots 6 and 9; thence in an Easternly direction to a point on said unnamed street that is the mid point of the front line of lot # 9; thence N. 46 W. 87.5 feet to the beginning corner.
