Douglas, his heirs and assigns forever, all of my undivided one-half interest in and to,

All that piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, being known and designated as Tract No. 15, as shown on a plat of the property of Parkins Lake Development, prepared by Dalton & Neves, Registered Engineers, in January, 1954, to be recorded in the R. M. C. Office for Greenville County, South Carolina, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern side of East Parkins Lake Road, which iron pin is approximately 784.7 feet from the intersection of Parkins Lake Road, and running thence S. 36-0 E. 1009.7 feet to an iron pin; thence N. 33-50 E. 1330 feet to an iron pin; thence N. 56-15 W. 419.5 feet to an iron pin on the Southern side of East Parkins Lake Road; thence along the Southern side of the said road, S. 38-35 W. 110.4 feet to an iron pin; thence S. 57-48 W. 229.2 feet to an iron pin; thence S. 68-54 W. 300 feet to an iron pin; thence S. 63-18 W. 100 feet to an iron pin; thence S. 52-03 W. 180 feet to an iron pin; thence S. 62-12 W. 84.6 feet to an iron pin; thence S. 84-39 W. 138.9 feet to an iron pin, the point of beginning.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

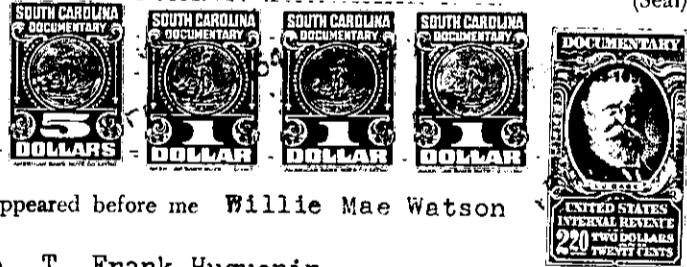
TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

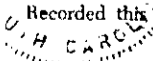
