All that piece, parcel or lot of land in Greenville County, State of South Carolina, being known and designated as lot No. 156, Section 2, of Caroline Court recorded in the RMC Office for Greenville County in Plat Book GG at page 21 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at the southwestern intersection of Manchester Avenue and Milady Street and running thence with Milady Street S. 25-15 W. 240 feet to an iron pin, joint rear corner of lot Nos. 156 and 171; thence with the joint line of said lots N. 64-45 W. 100 feet to an iron pin, joint rear corner of lot Nos. 156 and 157; thence with the joint line of said lots, N. 25-15 E. 240 feet to an iron pin on the southern side of Manhattan Avenue; thence with the southern side of Manhattan Avenue S. 64-45 E. 100 feet to the point of beginning.

This conveyance is subject to the following covenants, conditions and restrictions.

"That the said lands shall not be sold, rented or otherwise disposed of to any Negro or person of African descent. No residence to cost less than Seven thousand and five hundred (\$7,500.00) Dollars shall be erected on said lots; and no residence shall be erected on lots nearer the front line than building line as shown on plat; and no residence shall be built on any lot unless said lot has 50 feet, or more, frontage; no outside toilets permitted and sewage to be disposed of by approved septic tanks. No business buildings shall be erected on any lot other than lots fronting on U. S. Highway #29."
