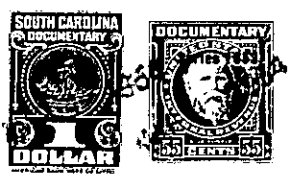
Know All Men by These Presents:

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said C.W. Funk, his heirs and assigns forever:

All that certain piece, parcel, lot or tract of land lying, situate and being in Gantt Township, Greenville County, South Carolina, and known and designated as Lot No. 8 of the R.L. Rollins property, according to survey made by W.J. Riddle, Surveyor, May 1951, and having the following metes and bounds:

BEGINNING at an iron pin in the elbow of Reeves Road and running thence with Reeves Road South 0-28 E. 180 feet to line of Lot No. 7; thence with line of said Lot No. 7 N. 88-21 W. 165 feet to joint rear corner lots Nos. 7, 8 and 9, said plat; thence with joint line of said lots Nos 8 and 9 N. 21-13 E. 214.2 feet to Reeves Road; thence with Reeves Road S. 73-50 E. 89.4 feet to the point of beginning, and being a portion of the property conveyed to R.L. Rollins by W.H. Burns et al by E. Inman, Master, by deed dated November 27, 1945 and recorded in the Office of Register of Mesne Conveyance in and for Greenville County in Deed Book 283, page 257, and is bounded on the North and East by said Reeves Road.
