That I, J. B. Hall, of Greenville County,

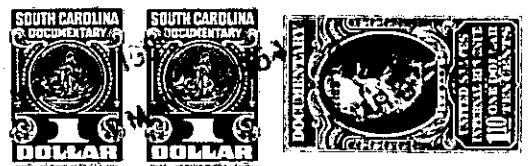
in consideration of the sum of Six Hundred and No/100 - - - - - (\$600.00) - - - - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee, Dorothy Farrell, her heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the north side of North Haven Drive, near the City of Greenville, being known and designated as Lot No. 54 of a subdivision known as Buncombe Park as shown on plat thereof recorded in the R. M. C. office for Greenville County, S. C., in Plat Book "M" at page 12, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of North Haven Drive at the joint front corner of Lots Nos. 53 and 54, and running thence with the joint line of said lots, N. 3-20 W. 234 feet to an iron pin; thence N. 88-00 E. 63 feet to an iron pin at the joint rear corners of Lots Nos. 54 and 55; thence along the joint line of said lots, S. 3-20 E. 234 feet to an iron pin on North Haven Drive; thence with said drive, S. 88-00 W. 63 feet to the beginning corner; being one of the lots conveyed to me by Evelyn C. Waddill by her deed dated July 19, 1951 and recorded in the R. M. C. office for Greenville County in Vol. 438, at page 324.

The above described property is subject to the restrictions set forth in deed recorded in Deed Book 303 at page 410, and also subject to such easements and rights-of-way for utility purposes as may be of record in said R. M. C. office.
