BEGINNING at an iron pin on the Southern side of Manhattan Boulevard at joint front corner of Los Nos. 58 and 59 and running thence with the joint line of said lots S. 25-15 W. 240 feet to an iron pin on line of lot 48; thence along the joint line of Lots 58, 48 and 49 N. 64-45 W. 85 feet to an iron pin, joint rear corner of Lot Nos. 58 and 57; thence along the joint line of said lots N. 25-15 E. 240 feet to an iron pin on the Southern side of Manhattan Boulevard; thence with Manhattan Boulevard S. 64-45 E. 85 feet to the beginning corner.
