Know All Men by These Presents:

That I, Paul N. Bayne, of Greenville County,

in consideration of the sum of Eighteen Hundred and No/100 - - - - - (\$1800.00) - - - DOLLARS, and the assumption of mortgage set out below to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee, James C. Blanton, his heirs and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, being known and designated as Lot No. 105 according to a plat of property of B. F. Martin, known as Westview, being recorded in the R. M. C. office for Greenville County in Plat Book F, at page 140, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of King Street, joint front corner of Lots 104 and 105, and running thence with the joint line of said lots, in a southwesterly direction, 150 feet to an iron pin at the rear corner of Lot 117; thence along the rear line of Lot 117, S. 46-45 E. 61 feet to an iron pin at the joint rear corner of Lots 105 and 106; thence with the joint line of said lots, in a northeasterly direction, 150 feet to an iron pin on the south side of King Street; thence along the south side of King Street, N. 46-45 W. 61 feet to the beginning corner; being the same conveyed to me by Local Home Builders, Inc. by deed dated October 15, 1953 and recorded in the R. M. C. office for Greenville County in Deed Book 487, at page 243.

The above described lot is shown on the Township Block Book at Sheet 226, Block 8, Lot 8, and the grantee is to pay taxes for the year 1954.

The grantee herein expressly assumes and agrees to pay the balance due on a certain note and mortgage executed on October 15, 1953 in the original sum of \$9775.00 by the grantor in favor of First Federal Savings and Loan Association of Greenville, recorded in the R. M. C. office for Greenville County in Mortgage Book 576, at page 261, on which there is a balance due of \$ 9,711.66 as of this date.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
