ALL that piece, parcel or lot of land in the City of Greenville, State of South Carolina, known and designated as Lot No. Four (4) on plat of Carver Park Addition made by the Piedmont Engineering Service, February, 1953, and recorded in the R.M.C. Office for Greenville County in Plat Book DD, page 72, and having according to said plat the following courses and distances, to wit:

BEGINNING at an iron pin on the east side of Carter Street, joint front corner of Lots 3 and 4 and running thence along the line of Lot No. 3 S. 89-44 E. 116.3 feet to an iron pin on line of Lot No. 6; thence along the line of Lot No. 6 S. 42-20 W. 67.3 feet to an iron pin corner of Lot No. 5; thence along the line of Lot No. 5 N. 89-44 W. 124 feet to an iron pin on Carter Street; thence along Carter Street N. 0-16 E. 50 feet to the beginning corner.
