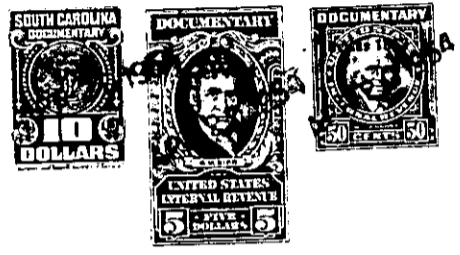
Know All Men by These Presents:

McIntyre her heirs and assigns forever that certain lot or parcel of land, with the improvements thereon, in School District 5, Chick Springs Township, said County and State, containing six (6) acres, more or less, and shown as part of Tract "3" on plat of the J. F. Flynn Estate, by H. Brockman, February 17th, 1953, and having the following courses and distances, to

begin at an iron pin on the East side of a new proposed road, McDowell's corner, and run thence along McDowell's line, N 31-05 E two hundred ninety-five (295) feet to twin R.C. tree; thence S 83-54 E five hundred two (502) feet to Norton's corner; thence E 19-30 E four hundred twenty (420) feet along the airview road to an iron pin; thence S 83-20 E seven hundred ninety-two and five-tenths (792.5) feet to an iron pin on the said new proposed road; thence S 1-03 E five hundred forty (540) feet to the beginning corner.
