in consideration of the sum of Eighteen Thousand Nine Hundred and No/100 - - - - - DOLLARS,

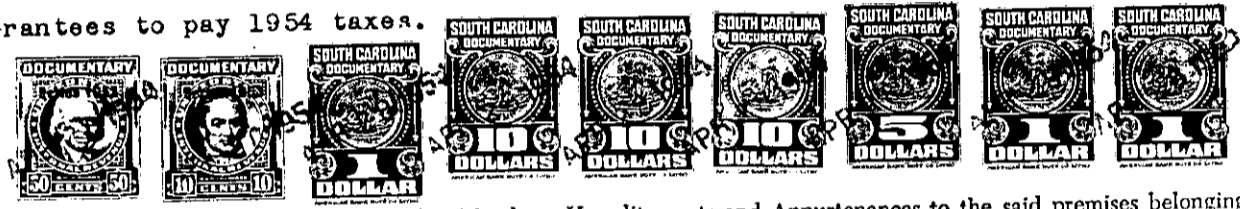

All that lot of land with the buildings and improvements thereon, situate on the south side of Dellwood Drive, in the City of Greenville, in Greenville County, S. C., being shown as Lot No. 7 on plat of property of C. A. Harvin, Jr. and J. K. Buff, made by Dalton & Neves, Engineers, August 1952, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "CC", at Page 143, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of Dellwood Drive, at joint front corner of Lots 6 and 7 and running thence along the line of Lot 6, S. 1-11 E. 189 feet to a point in the center of a branch; thence down the branch (the traverse line being S. 88-10 W. 78 feet) to a point in the center of branch, the joint rear corner of Lots 7 and 8; thence with the line of Lot 8, N. 0-47 W. 188.7 feet to an iron pin on the south side of Dellwood Drive; thence along the south side of Dellwood Drive, S. 86-45 E. 77 feet to the beginning corner.

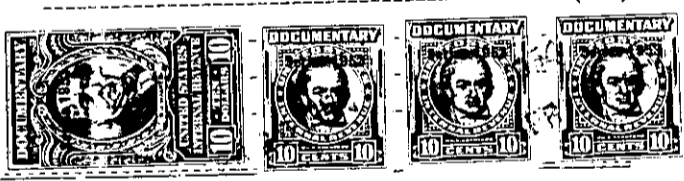
