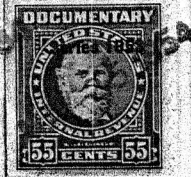

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release
unto the said Mrs. Ida Iola Ball, all the right, title and interest of
Virginia Sue Ball, the same being an undivided 1/6th interest in and
to the following real estate:

Located in Ward 5 of the City of Greenville, on the East side of
Markley Street, containing 5310 square feet, more or less, and having
the following metes and bounds, to-wit:

Beginning at an iron pin on corner of Mrs. M. J. Richardson's lot
and running thence along the East side of Markley Street N. 18 1/2 E.
59 feet; thence S. 70 E. 90 feet to an iron pin; thence S. 18 1/2 W.
59 feet to iron pin on the Mrs. Richardson's line; Thence along
Richardson's line N. 70 W. 90 feet to the beginning corner, bounded
by lands of Mrs. M. J. Richardson, Markley Street and Hattie Carpenter,
