presents do grant, bargain, sell and release unto the said Pansy P.Garrison

A one half(I/2) interest in and to all my rights, titles and interest,
of, to and in

all that piece, parcel or lot of land in Grove Township, Greenville

County, State of South Carolina and known as Tract No.6 in the division of the
lands of the Estate of T.J.Garrison, deceased, and having an Area of
Forty and four tenths(40-4/10) Acres, more or less, adjoining Tracts
Nos. 1,3 and Seal Flemming and others. For a more complete description
of the herein conveyed land reference is made to a plat of said
