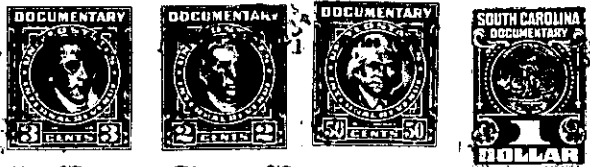

Know All Men by These Presents:

That We, Kelly Turner and Winnie Turner in the State aforesaid, in consideration of the sum of Four Hundred Seventy-Five and No/100 (\$475.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Gary V. Jones, his heirs and assigns forever:

All that lot of land situate, lying and being on the East side of Linda Lane, east of the Old Buncombe Road, near the City of Greenville, in Greenville County, State of South Carolina, shown as lot 89, on plat of Casa Loma Estates, made by Piedmont Engineering Service, October 1947, recorded in the R.M.C. Office for Greenville County, S.C. in Plat Book S at Page 65, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the East side of Linda Lane, at joint front corner of lots 89 and 90, and running thence with the line of lot 90, S. 80-45 E. 160 feet to an iron pin; thence with the line of lot 88, N. 12-20 W. 179.2 feet to an iron pin on the South side of Courtney Circle; thence along the South side of Courtney Circle, S. 77-40 W. 66.6 feet to an iron pin; thence continuing with the curve of Courtney Circle and Linda Lane (the chord being S. 43-27 W. 57.9 feet) to an iron pin on the East side of Linda Lane; thence along the East side of Linda Lane, S. 9-15 W. 94.6 feet to the beginning corner.

Being the same premises conveyed to the grantors by deed recorded in Book of Deeds 442 at Page 290.

Grantee is to pay 1954 taxes.
