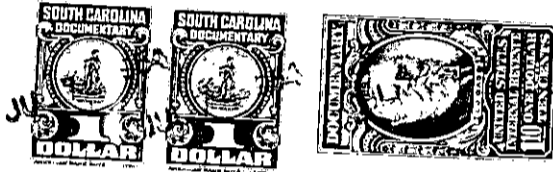
That I, R. E. Hughes in the State aforesaid, in consideration of the sum of Six Hundred Fifty (\$650.00)----- DOLLARS,
