All that piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 80, Section I of Lake Forest, as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "GG", page 17, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northerly side of Lake Fairfield Drive, joint front corner Lots 79 and 80, and running thence N. 29-46 W. 169.3 feet to an iron pin, joint rear corner Lots 56.57, 79 and 80; thence N. 59-24 E. 98 feet to a point; thence N. 63-28 E. 25.6 feet to an iron pin, joint rear corner Lots 80 and 81; thence S. 24-47 E. 168.5 feet to an iron pin on the Northerly side of Lake Fairfield Drive, joint front corner Lots 80 and 81; thence along the Northerly side of Lake Fairfield Drive S. 61-43 W. 110 feet to an iron pin, the point of beginning.
