GODFREY, his heirs and assigns, forever:

ALL that lot of land on the North side of Nottingham Road, near the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 180 on Plat of Sherwood Forest, made by Dalton & Neves, Engineers, August, 1951, revised through December, 1953, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book 'GG', at pages 70 and 71, and having according to said plat, the following metes and bounds, to wit:
