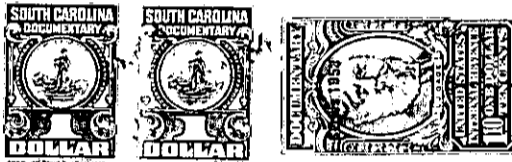
All that lot of land situate lying and being on the east side of Linda Lane east of the old Buncombe Road, near the City of Greenville, in Greenville County, State of South Carolina, shown as lot 89 on plat of Casa Loma Estates made by Piedmont Engineering Service, October, 1947, recorded in the R. M. C. Office for Greenville County, S. C., in plat book S at page 65, and having according to said plat the following metes and bounds to-wit:

BEGINNING at an iron pin on the east side of Linda Lane at joint front corner of lots 89 and 90 and running thence with the line of lot 90 S. 87-45 E. 160 feet to an iron pin; thence with the line of lot 88 N. 12-20 W. 179.2 feet to an iron pin on the south side of Courtney Circle, thence along the south side of Courtney Circle, S. 77-40 W. 66.6 feet to an iron pin; thence continuing with the curve of Courtney Circle and Linda Lane (the chord being S. 47-27 W. 57.9 feet) to an iron pin on the East side of Linda Lane; thence along the east side of Linda Lane S. 9-15 W. 94.6 feet to the beginning corner.

Being the same premises conveyed to the grantors by deed recorded in Deed Book 442 at Page 290.

The above described premises are subject to the restrictive covenants recorded in Deed Book 344 at Page 51.
