Know All Men by These Presents:

That We, Glenn F. Winchester and Myra P. Winchester, in the State aforesaid, in consideration of the sum of Five Thousand, Five Hundred and no/100 - - - - - (\$5,500.00) - - DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee, Charlie W. Lesley, his heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Chastain Drive, which drive intersects North Franklin Road and being known and designated as Lot No. 7 according to the plat of property of G. C. Chastain, made by W. J. Riddle, dated October, 1951 and recorded in the R. M. C. office for Greenville County in Plat Book AA, page 175, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Chastain Drive, corner of property conveyed to M. W. Massey in Deed Book 455, page 477, known as Lot No. 6, and running thence along the line of Lot No. 6, N. 86-57 W. 322.4 feet to an iron pin, joint rear corner of Lots Nos. 6 and 7; thence along the eastern line of a 27-foot strip as shown on said plat, S. 6 W. 75 feet to the joint corner of Lots Nos. 7 and 8; thence along the line of Lot No. 8, S. 89-15 E. 332 feet to an iron pin on the western side of Chastain Drive, joint front corner of Lots Nos. 7 and 8; thence along Chastain Drive, N. 2-34 W. 62 feet to an iron pin, joint front corner of Lots 6 and 7 to the beginning corner; being the same conveyed to Glenn F. Winchester by G. C. Chastain by deed dated July 15, 1952 and recorded in the R.M.C. office for Greenville County in Vol. 459, page 212, the said Glenn F. Winchester having conveyed an undivided one-half interest in said property to Myra P. Winchester by deed dated July 29, 1952 and recorded in the R.M.C. office for Greenville County in Vol. 460, page 84.

Reference is to be had to another plat of property of G. C. Chastain by Dalton & Neves, dated June, 1952, and recorded in the R.M.C. office for Greenville County in Plat Book CC, page 103.
