to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Trustees of the Greenville County School District No. 520, their successors and assigns:

ALL that certain piece, parcel or lot of land on the South side of Eighth Street in Section 5 of Judson Mills Village, being known and designated as Lot No. 1 on a plat of Section 5 of Judson Mills Village by Dalton & Neves, Engineers, dated February 1940, and recorded in the R.M.C. Office for Greenville County in Plat Book "K" at pages 33 and 34, and being more fully described as follows:

BEGINNING at an iron pin on the South side of Eighth Street, joint front corner of Lots Nos. 1 and 2, said pin being 268 feet West from the Southwest corner of Eighth Street and Hawkins Avenue and running thence with the line of Lot No. 2, S. 1-55 E. 150 feet to an iron pin; thence S. 88-03 W. 81 feet to an iron pin; thence N. 1-55 W. 150 feet to an iron pin on the South side of Eighth Street; thence with the South side of Eighth Street, N. 88-03 E. 81 feet to the point of beginning.
