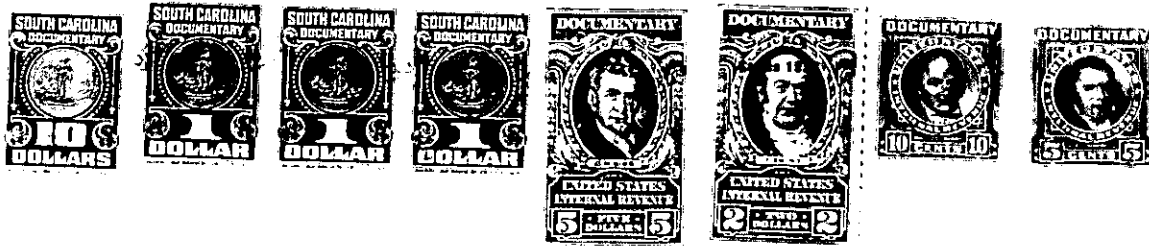
Know All Men by These Presents:

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Trustees of the Greenville County School District No. 520, their successors and assigns:

ALL that piece, parcel or lot of land situate, lying and being on the South side of Eighth Street in Section 5 of Judson Mills Village, being known and designated as Lot No. 2 on a plat of Section 5 of Judson Mills Village by Dalton and Neves, Engineers, dated February 1940, and recorded in the R.M.C. Office for Greenville County in Plat-Book "K" at pages 33 and 34, and being more fully described as follows:

BEGINNING at an iron pin on the South side of Eighth Street, joint corner of Lots Nos. 2 and 3, said pin being 187 feet West of the South-west intersection of Eighth Street and Hawkins Avenue and running thence with the line of Lot No. 3, S. 1-55 E. 150 feet to an iron pin; thence S. 88-03 W. 81 feet to an iron pin; thence with the line of Lot No. 1, N. 1-55 W. 150 feet to an iron pin on the South side of Eighth Street; thence with the South side of Eighth Street, N. 88-03 E. 81 feet to the beginning point.



TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their successors and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
