All that piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 23, Hudson Acres, as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "Y", page 39, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Easterly side of Hudson Drive, joint front corner Lots 22 and 23, and running thence S. 63-20 E. 222.7 feet to an iron pin, joint rear corner Lots 22 and 23; thence N. 19 E. 105 feet to an iron pin, joint rear corner Lots 23 and 24; thence N. 31-30 W. 154.3 feet to an iron pin on the Southerly side of Greenwood Avenue; thence along Greenwood Avenue S. 60-10 W. 65 feet to a point; thence continuing along Greenwood Avenue S. 77-40 W. 90 feet to a point in the curve of the intersection of Greenwood Avenue and Hudson Drive; thence around the curve, the chord of which is S. 47-55 W. 35 feet to a point on the Easterly side of Hudson Drive; thence around the Easterly side of Hudson Drive S. 6-W. 60 feet to an iron pin, the point of beginning.
