Godfrey Webster in the State aforesaid, in consideration of the sum of Ten (\$10.00) DOLLARS, love and affection to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Jessie D. Webster,

All that piece, parcel or tract of land in the city of Greenville, county of Greenville, state of South Carolina containing 5.68 acres, more or less, being a western portion of that tract of land shown on plat of Mrs. A. C. Webster land, et al, dated August 17, 1921 recorded in plat book F page 4 of the R. M. C. Office for Greenville County, and having according to a recent survey made September 15, 1954 by Piedmont Engineering Service, the following metes and bounds, to-wit:

Beginning at an iron pin, the joint corner of the property being hereby conveyed, Carver Park Addition, and Greenville Housing Authority, and running thence with the line of said Carver Park Addition, N. 63-11 W. 438.4 feet to an iron pin; thence N. 52-58 E. 663.1 feet to an iron pin corner of property of Leslie and Shaw, Inc.; thence with the line of said property S. 60-07 E. 216.4 feet to an iron pin; thence continuing with line of said property S. 50-35 E. 171.3 feet to an iron pin; thence continuing with the line of said property S. 25-03 W. 36.7 feet to an iron pin, corner of property of Greenville Housing Authority; thence with the line of said property S. 52-31 W. 536.5 feet to the beginning corner. This tract of land is located at the eastern end of Celand and Laco Streets.
